Lui Chi Woo Building Renovation & Expansion Project
Lui Chi Woo Building will be used as Comprehensive Administration Building in Fudan University, which includes president office, key departments offices and kinds of meeting rooms. In 2008, Dr. Lui Chi Woo pledged to donate a total sum of USD 3.8 million for the renovation & expansion of this building in the following years.
In 2009, Lui Chi Woo building renovation project was approved by Ministry of Education of China. And in the same year, the building renovation construction was started. Following the donation agreement and building construction contracts, the second phase payment in the amount of USD 1,880,000 is granted to Fudan University.

4b (Code) (Expenses \$ 1,200,000 including grants of \$ 1,200,000) (Revenue \$)
Leo Koguan Law Building Grants
Leo Koguan Law Building is used for the Law School of Fudan University for teaching and research purposes mainly, which includes classrooms, moot court, scientific research center and faculty offices.
In 2010, Leo Koguan Foundation promised to donate a total sum of USD 6 million within 5 years for the general purpose of repayment of the construction costs and covering other expenses related to the renovation, upgrading, maintenance and upkeeping of the Law Building. In the same year, the first installment in the amount of USD 1.2 million was received, and then granted to Fudan University according to the donation agreement.

Center for Shanghai History Studies in Fudan University
Center for Shanghai History Studies is established to deepen the research on Shanghai History and promote related academic communications. In 2009, Mr. Chu promised to donate a total sum of 750,000 within 5 years for supporting center's activities.
In 2010, the first installment in the amount of 150,000 was granted to the center for research data collecting, seminar and conference hosting, famous scholar inviting, and research facility purchasing.

2010Y New Grant Program. Leo Koguan Law Building Project

Leo Koguan Law Building is used for the Law School of Fudan University for teaching and research purposes mainly, which includes classrooms, moot court, scientific research center and faculty offices. In 2010, Leo Koguan Foundation promised to donate a total sum of USD 6 million within 5 years for the general purpose of repayment of the construction costs and covering other expenses related to the renovation, upgrading, maintenance and upkeep of the Law Building. Following the donation agreement, the 1st installment was received and granted to Fudan University.

2 Answer to Form 990, Part III, Line 4d: Other Program Services

Besides those program described on 4a-4c, our foundation gave grants, totally US\$ 238,142, to other five (10) programs.

(1) Leo Koguan Best Performance Students Scholarship, totally grants US\$ 49,500

The scholarship is granted to total thirty-three(33) Best Performance undergraduate and graduate students selected and approved annually by the University scholarship accreditation committee. Of the annual 33 selected Best Performance students, 7 are earmarked for students of law, 7 for students of economics, 7 for students of philosophy and another 12 for other disciplines of Fudan University respectively. Each student was awarded USD 1,500.

(2) Leo Koguan Financial Assistance Scholarship, totally grants US\$ 49,500

This scholarship is granted to total thirty-three(33) undergraduate and graduate students annually from poor income families who academically sound but in need of financial assistance. Of the annual 33 selected students, 7 are earmarked for students of law, 7 for students of economics, 7 for students of philosophy and another 12 for other disciplines of Fudan University respectively. Each student will be awarded USD 1,500.
