

The program focuses on supporting crop generic improvement and seed supply for Africa. It takes a value chain approach, starting with training new scientists and ending with putting improved seeds on the shelves of village-level agro-dealers.

- 2 - The Fund for the Improvement and Adoption of African Crops ( FIAAC)
- 3 - The Seed Production for Africa ( SEPA)
- 4 - The Agro-Dealers Development Program ( ADP)
