WHEREAS, the current Board of Directors desire to revise the number of directors to ten (10) members.

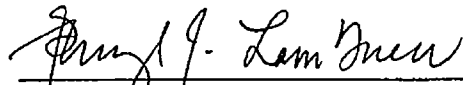
