We believe that Jesus Christ is the answer for all suffering, both for those with plenty in the United States and those living in poverty abroad. Three Strand Cord is committed to enriching the lives of those afflicted, spiritually and physically, by creating connections between those who can give and those who need to receive. Three Strand Cord aims to empower both groups, the local community to grow until they can rely only on the Lord and the donors to give in a way that places them firmly in His hands.

OASIS PROJECT: Through the Oasis Project, Three Strand Cord coordinates the establishment of sustainable communities. A sustainable community, in our view, is a community that does not require outside aid to maintain a stable and healthy population. To form these communities, Three Strand Cord identifies partner organization to work with the Oasis Community to institute seven elements: clean water, renewable food sources, reliable power, comprehensive education, appropriate medical care, a thriving economy and Biblical discipleship. During the duration of the Oasis Project (5-7 years), Three Strand Cord also provides aid to the partner organization to maintain its programs while the Oasis work is being accomplished. The current Oasis Project is being done in partnership with the Centre for Evangelism and Development of Acul du Nord (CEDAN) in Limbé, Haiti. This year, the Oasis project was established, support provided to rebuild one of the main structures and support provided to provide food, education and to create a microloan program.

4b (Code:) (Expenses \$ 32,432 including grants of \$ 32,193) (Revenue \$ 0)

FOOD PACKING EVENTS: As part of the goal of creating "oasis" communities, Three Strand Cord has partnered with Kids Against Hunger and Change This World (both 501(c)3 organizations) to provide meals to those overseas as well as a way to engage those in the local community. Three Strand Cord acts as a booking agent to arrange food packing events as well as a coordinator to disburse the collected food. Each event allows the local community to engage in philanthropy as well as providing meals, locally and internationally. This year, Three Strand Cord organized the packing of over 150,000 meals.

4c (Code:) (Expenses \$ 32,121 including grants of \$ 30,859) (Revenue \$ 0)

SHORT TERM MISSION TRIPS: Three Strand Cord supports local churches within the United States who have long assisted overseas missionaries by sending short-term teams to aid work being accomplished in international locations. Through short-term missions teams, construction, medical, and evangelistic programs can be undertaken beyond the capacity of the missionary acting alone. Recognizing the power of the work done by these teams, the program identifies unfilled needs and finds funding and materials to meet those needs. In addition, Three Strand Cord pools the knowledge acquired through these projects to aid teams in maximizing effectiveness. Once the mission trips are completed, 3SC also maintains relationships with the in-country missionaries, as possible. This year, Three Strand Cord supported trips to Haiti, the Dominican Republic and Peru. As part of these trips, over 1,400 local people received food and medical care.

HAITI EARTHQUAKE RELIEF: In the wake of the overwhelming devastation caused by the natural disasters in Haiti, Three Strand
Cord is working with our in-country partners to alleviate the suffering. To date, 3SC has partnered with the Ecole Mixte Nazareth
schools to rebuild a system of schools which were damaged during the earthquake. So far, one school has been rebuilt and class
moved from the school yard (where they had been meeting) back into the building. But the needs of even this school system are
not yet complete. Three Strand Cord hopes to be able to continue this work by helping to rebuild the remaining 5 schools as well
as provide all needed supplies for a successful school year.
