It is offered to all Maine communities by the Masons and their affiliated organizations, Eastern Star, Rainbow Girls, DeMolay and Shrine. Volunteers work with law enforcement officers and dental professionals to provide fingerprinting, toothprinting, and videotaping services. During the fiscal year just completed, 419 Masons and 143 non-Masons volunteered at 103 one-two day clinics across the state. 2,065 children were served.The Foundation also provides financial support for activities conducted by local lodges. During the past year, an additional 1,982 Masonic volunteers participated in local community events such as support for:Boy and Girl Scouts (61 volunteers);Rainbow and Demolay activities (209 volunteers);VA Hospitals (112 volunteers);Project Graduation (207 volunteers);Peolple to People (127 volunteers);Food Pantry (172 volunteers);Books for Bikes (646);Youth Hockey (48 volunteers);Cemeteries and Parks (10 volunteers);Other community activities (390 volunteers)Because of the broad nature of its financial support and volunteer activity, and because of the number and nature of the community activities it conducts and supports, the Foundation believes that it meets the facts and circumstances test of IRC Section 509(a)(1).
