In addition to electing the eight members of the Board of Governors, the members vote each year as to whether to approve and adopt the annual financial budget.

PART XI, NUMBER 5: Net assets declined by \$24,344 this years because extensive repairs were needed for the Clubhouse. This included replacement of a roof and almost all of the windows. As a result, the club had revenues of \$131,858 but spent \$156,202, generating this decline in net assets.
