FOR THE 2007 (INITIAL YEAR), 2008, AND 2009 TAX YEARS, THE ORGANIZATION FILED FORM 990-EZ AND INADVERTENTLY SELECTED THE CASH BASIS METHOD OF ACCOUNTING. THE FORMS 990-EZ IN EACH YEAR HAD ACTUALLY REPORTED ACCRUAL BASIS BALANCES AND THE ACCRUAL METHOD OF ACCOUNTING SHOULD HAVE BEEN CHOSEN. THE CURRENT YEAR FORM 990 HAS PROPERLY SELECTED THE ACCRUAL BASIS METHOD OF ACCOUNTING IN PART XII.
