Youth educational outreach programs continue with grammar school through college-age students attending docent-led tours emphasizing the surfing heritage being passed to them by those who have gone before them.

Continued digital scanning and preservation of historical scrapbooks and photo collections results in our having the largest collection of historically significant surfing images in the world. These digitized collections are available for research and educational purposes.

In addition to the permanent collection exhibits, traveling exhibits have also been developed for public viewing at local events and various industry trade shows. The Foundation designed an exhibit on one of surfing's major innovators, Bob Simmons.
