PARTICIPANTS ARE BETWEEN THE AGES OF 14 AND 21 WITH THE EMPHASIS ON AGES 16-21. THE SENIOR EMPLOYMENT PROGRAM IS DESIGNED TO PROVIDE USEFUL PART-TIME OPPORTUNITIES IN COMMUNITY SERVICE EMPLOYMENT FOR LOW-INCOME PERSONS AGE 55 YEARS OR OLDER. THE ADULT EMPLOYMENT PROGRAM AND THE DISLOCATED WORKERS PROGRAM PROVIDE JOB COACHING AND TRAINING TO UNEMPLOYMENT INDIVIDUALS. WE ASSISTED 944 PEOPLE TO GAIN EMPLOYMENT OR EMPLOYMENT SERVICES.
