Part III – Statement of Program Accomplishments

During the year we held at least six community forums that resulted in our recruitment and training of at least 30 new clinic escorts. The organization has provided patient escorts at The Hope Clinic for Women and Planned Parenthood of the St. Louis Region for decades.

We worked extensively throughout the year with campus activists, most particularly Law Students for Reproductive Justice at Washington University in St. Louis, Med Students for Choice at Washington University in St. Louis, and undergraduate pro-choice activists on several Missouri college campuses. We were instrumental in efforts to found a Washington University chapter of Social Work Students for Choice, led by one of our former interns from our thriving summer internship program.

Our EC in the ER/Compassionate Assistance for Rape Emergencies (C.A.R.E.) work continued to be a priority. As a result of our Foundation's survey work, our affiliated lobbying arm was able to use our findings to testify in Missouri General Assembly hearings about the C.A.R.E. bill, which would require emergency room facilities to offer women who have been sexually assaulted the option of taking Plan B in the ER to avoid pregnancy. We created and mailed surveys to community medical centers regarding their knowledge of how EC works and their protocol for referring victims of sexual assault for EC, since we know that some women visit their regular doctors or community facilities rather than presenting themselves to an ER following a rape. We also sent them glossy fliers and informational sheets about the modalities of EC.

We conducted tabling events with Law Students for Reproductive Justice at Washington University in St. Louis, sent thousands of e-mail alerts about our EC in the ER campaign to activists, prepared press packets and letters to the editor to bring attention to the fact that the majority of Missouri's ER facilities do not offer women the option of EC in the ER, and conducted petition drives about the lack of access to EC in the ER.

We continued to work via social media to reach young activists and energize them for our work throughout the year.
