The Foundation exists to raise funds for new equipment and technology; develop new health related programs and services; enhance assisted living and long-term care services; support community wellness education; and provide scholarships and loans for nursing, allied healthcare professionals and physicians to meet the continuing changes in healthcare reform. To reach these goals, an endowment fund was established. The endowment fund will be used as a permanent

The Foundation also maintains the following other funds for donations and contributions. Support to these funds for this reporting period was as follows: General Endowment for \$37,282; ambulance for \$2,233; Good Neighbor Project (a program to assist qualifying individuals with their medical expenses) for \$8,731; Partners in Health (an annual giving club to assist with WRHS and WHLC equipment needs) for \$23,275; and Western Horizons Living Centers for \$1,731. All special funds are separately accounted for and used specific to the purpose intended.

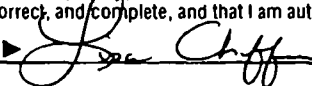
