The MHBA publishes the "Mid-Atlantic Thoroughbred", a four-color monthly magazine that covers racing and breeding in Maryland and throughout the region. In addition, MHBA publishes an annual guide to thoroughbred farms in Maryland and various posters, brochures and guides that educate the public about racing and breeding in the State of Maryland.

MHBA functions as an information resource for horse breeders and owners, the media, community and governmental organizations, and the general public. Breeders and owners register their Maryland bred horses with the association in order to qualify for specific races restricted to Maryland - Breds.

Seminars are held for members and the general public to educate on topics relevant to the horse industry.
