

In fiscal year 2010, LEAP continued its programs to provide medical services as a part of the Haiti disaster relief project by providing 20 fully equipped surgical teams. These teams treated over 1000 patients. LEAP also assisted in the provision of basic medical care to orphaned children at Haiti Children's Relief Mission. The LEAP surgical teams performed surgical reconstructions to both adults and to children. Medical professionals donated 923 days of volunteer time to the Haiti projects and outreach. The estimated value of the volunteer time is over \$600,000.

4b (Code) (Expenses \$ 82,393. including grants of \$ 660.) (Revenue \$ 0.)

LEAP provided medical surgical teams to the country of Zimbabwe to work in conjunction with the Zimbabwean Ministry of Health. The teams performed more than 40 complex cleft and craniofacial reconstructions in addition to providing training to the local medical community. Medical professionals donated approximately 130 days of volunteer time to the Zimbabwe outreaches. The estimated value of the volunteer time is over \$100,000.

4c (Code) (Expenses \$ 72,499. including grants of \$ 500.) (Revenue \$ 0.)

LEAP provided medical surgical teams to India to continue its work with the Central India Christian Ministry. More than 70 children received reconstructive life changing surgery. Medical professionals donated approximately 250 days of volunteer time to the Indian outreaches. The estimated value of the volunteer time is over \$150,000.
