The purpose of the Montana Wool Growers Association is to protect the interests of persons raising sheep in Montana. The Association has been operating since January 1883. The Association also promotes, when possible, the two products from sheep, wool and lamb. The Association keeps the membership informed about many issues including, animal health, marketing, government regulations, news about fellow producers by publishing the Montana Woolgrower five to six times a year.

MWGA, for 61 years, has also sponsored a ram sale allowing Montana consignors to sell the best of their male breeding stock to Montana and other states' producers. The sale offers an opportunity to find better genetics to improve the commercial flocks of the nation. The MWGA holds a membership meeting/convention at which time we present speakers on a variety of subjects of interest to sheep producers. At that meeting the membership votes for directors and the President of the Association. Members can express their views on the operation of the Association or issues facing the industry.
