The ACLU of NM undertakes litigation, advocacy and public education to advance and defend constitutional rights with an emphasis on issues that have broad impact. Our litigation and legal advocacy work seeks to establish case law and policy precedents that protect or expand civil liberties. In 2010-11 our legal program operated with three staff attorneys and 25 volunteer cooperating attorneys who donated \$280,955 in legal services. Our team of attorneys represent ordinary people who have experienced an injustice and have decided to reclaim their rights. The ACLU of NM litigates over 50 cases annually. A large portion of the work of the ACLU of NM involves informing the public through media and community events about the importance of preserving individual rights and liberties. The organization utilizes pro-active and strategic media communications and public education to insert civil libertarian perspectives into dominant news media discourse in ways that energize the public's commitment to freedom.
