Agency Funding: We partner with businesses, non-profits, governments and individuals to raise funds supporting health and human service needs in our county. Voluntary board and community members determine the most critical and emerging needs. Funds raised are distributed to non-profit health and human service agencies as allocated by the board and directed by the donors. Funded agencies are required to document outcomes and are monitored by the United Way board.

United Way serves as a resource to 3 local governments: Clallam County, the City of Port Angeles, and the City of Sequim, administering the grant process for their health and human service funds. This entails working with each local government to identify critical priorities to be funded, marketing the availability of grants to local community organizations, accepting and reviewing grant applications, making recommendations to the government leaders (City Councils and County Commissioners), and monitoring outcomes and reporting back on the grants. This role demonstrates the respect and value held by community leaders for the work of the United Way of Clallam County.

Community Solutions: To make a significant difference in our community, we must engage in strategic community building. We call this Community Solutions. We identify our county's most significant problems, and convene people, organizations, government and resources to strategically address the problem. Our current projects include: 1) the Access to Health Care Coalition works to help all people access health care including primary, specialty, behavioral health and dental care, 2) 211 Access to Help - a simple phone number to connect people to health and human resources in our county, and 3) the Clallam County Literacy Council works to expand literacy resources, provide free adult tutoring, encourage families to read to their children, and get books into the hands of children living in poverty.
