Low priority will be given to applications for debt reduction, salaries, fund raising projects, contributions to endowments, or projects where the grant is the sole funding source.

The Advisory Committee will review applications once a year. Grant Applications need to be submitted no later than September 30. The Committee will announce the winners in December with the grants being distributed by March 31.
