The scholarships are awarded strictly based on their volunteer efforts.

Every Fall, the Research and Recommendation Committee (RRC) of the Board of Directors distributes

nomination forms into the community and to all local high schools. These forms are also available on our website.

After the nomination period closes on November 30, every nominee is researched. Top youth nominees are interviewed by a panel of committee members. The RRC forwards its recommendations to the Board of Directors.

The top student recipient receives a \$10,000 scholarship. An additional \$500 is directed to a charity of their choice.

This year, 24 student volunteers were awarded \$5,000, and 2 top student volunteers were awarded \$10,000 scholarships provided by local businesses and individuals.

The purpose of the Sequoia Awards is to recognize local Redwood City students for their volunteer efforts and to encourage younger students to give back to their community through volunteerism.
