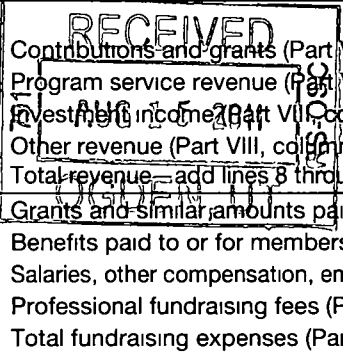

Spring Sahavas Retreat Gathering - May 2010: Devotional 3-day gathering dedicated to the life and teachings of Avatar Meher Baba. Food and basic necessities were provided for the program of devotional songs, prayers, talks by guest speakers, workshops, and dramatic presentations. A children's program was organized with crafts and other activities. Staff were all volunteers. Expenses were incurred for food, supplies, equipment rental, site preparation, advertising and promotion, and travel cost of guest speakers. Approximately 140 people attended.

4b (Code:) (Expenses \$ 86352 including grants of \$) (Revenue \$ 87746)
40-Day Ongoing Retreat - May/June 2010: Ongoing retreat with talks by guest speakers, devotional songs, prayers, media presentations, workshops, group sharings, and dramatic presentations. There was a children's program featuring crafts and other activities. Staff were all volunteers. Expenses were incurred for food, supplies, equipment rental, site preparation and upkeep during the event, advertising and promotion, and guest travel and accommodation. Approximately 430 people attended over the course of the retreat.
