The NEDA Informational and Referral Helpline and website are nationwide, free resource linking sufferers and their loved ones to vital information, support and a referral database with hundreds of eating disorders treatment professionals. NEDA provided 40 live hours of helpline service each week thanks to a Helpline Supervisor and dozens of trained volunteers.

The Helpline characteristically receives a significant increase in call volume during National Eating Disorders Awareness Week (annually the last week of February). This past year the Helpline experienced the predicted increase in calls beginning in January with an even higher peak in number of calls in February than in previous years. This

Held annually since 1987, National Eating Disorders Awareness Week (NEDAwareness Week) is the largest collaborative eating disorders outreach effort in the nation and has expanded to many countries throughout the world. Thousands of community partners distribute NEDA's educational materials and coordinate outreach activities that attract public and media attention to the severity of eating disorders, signs and symptoms, and where to go for help and resources. In 2011, we registered more than 3,000 participants in all 50 states and 29 other countries, representing a 70% increase over last year and a 400% increase in the last two years. A past NEDAwareness Week participant reported, "I know that in my college community, a lot of people are suffering in silence, so if anything, at least, I think that

The Annual NEDA conference provides an opportunity for family members, treatment providers, health educators and eating disorders activists to connect and share information that can be transformed into action. The 2010 Conference: "Building Bridges to Recovery" was held in New York, NY hosted more than 580 attendees representing 41 states and 2 countries outside the U.S.
