In FY 2010 PCs for People collected almost 5,000 computers and laptops. Over the course of the year these PCs were refurbished and distributed to low income families. A total of 2,094 PCs were distributed. PCs for People also supports the computers distributed with a 90 day warranty and does discounted repairs after the warranty period. Repairs are \$25 and any parts needed are free. In FY 2010 713 repairs were completed at an average cost of just over \$20 per repair.

In FY 2010 PCs for People worked on a project to deliver 1,000 computers to rural MN cities. During the fiscal year 600 of the 1,000 computers were distributed to 11 different cities across the state.
