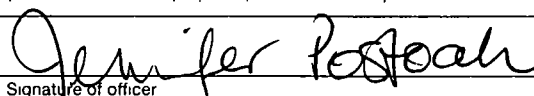

Hospital and Patient Support

The Medical Guild annually awards grants to various departments of the J Hillis Miller Health Science Center at the University of Florida, various departments of Shands Teaching Hospitals and Clinics, Inc and various affiliates of the University of Florida and Shands Teaching Hospital and Clinics that support health and the well-being of the community. Awards are decided upon by the Guild members, ensuring specific criteria set forth by the Guild is met. During the 2010 tax year, the Medical Guild granted \$29,441 to Shands Teaching Hospital in support of hospital departments and initiatives. The Guild annually donates \$8,000 to the department of Patient and Family Resources, which use donated funds to help patients and their families purchase basic items, like blankets, monthly medications, or medical equipment.
