The executive committee reviews and recommends the compensation level for the president through the use of the same information described above for other employees. During the annual budget process, the president includes the recommended compensation levels for all employees in the budget. Upon presentation of the budget to the executive committee of the board, the committee reviews the recommended compensation levels and has the authority to adjust the salary as deemed appropriate. After approval by the executive committee, the entire board of directors considers and approves the compensation level by approval of the annual budget.
