Reason for Amendment

The taxpayer has amended the 2010 Form 990-PF to reclaim the \$1,708 of tax paid. At the time of preparation, the tax preparer was informed that this trust should be treated as a Private Foundation according to section 1241(c) of the Pension Protection Act and accordingly filed Form 990-PF. On February 1, 2012, the organization sent a request for a ruling classifying them as an organization described in section 509(a)(3) of the Internal Revenue Code. On April 6, 2012, the Internal Revenue Service determined that they are not a private foundation because they are a Type III supporting organization (see attached). Accordingly, the tax payer requests a refund of the section 4940 excise tax.
