

By-Laws Changes:

In 2007 the Society of Ethnobiology members voted by mailed ballot to amend the Society's By-Laws as follows.

Amendment 5. The number of elected Board-Members-At-Large (who serve three-year terms) shall be increased from three to six by replacing each retiring board member with two elected board members each year for the next three years.

In fiscal year 2008 at the general meeting (April 3, 2009) the society voted to separate the Secretary-Treasurer board position into two positions "Secretary" and "Treasurer," which raised the board number to 10 from 9.

In fiscal year 2009 at the general meeting (May 7, 2010) the society voted to eliminate one of the unfilled at-large board positions to reduce the board number back down to 9.
