Oakland Metro Operahouse - We provide a community venue to local non-profits and arts organizations, an affordable theater for them to produce their own works. In the last fiscal year, we housed almost 200 shows. Since 2007, Oakland Opera Theater, in conjunction with our landlords Terredev Jefferson, has worked tirelessly to open a state of the art performing arts center. We completed a full seismic retrofit, plumbing for concessions and bathrooms, facade improvements, fixed steel lighting grid and full sound reinforcement. We are pleased to be able to offer our space to local organizations struggling to find accessible spaces to showcase their works. We offer below market rental rates to nonprofits and theater producers, and have provided Oakland with a community venue that houses all sorts of wonderful organizations such as Bay Area Girls Rock Camp, New Style Motherload, Bay Area Pride, and more

During the 2010 - 2011 fiscal year, the Oakland Opera performed a opera Jesus and his Mom, a multi media exploration of the crucifixion. Updated score based on J S Bach Cantata # 147 and Pergolesi Stabat Mater. A collaboration with Bay Area Classical Harmonies and New Style Motherload Dance company. Jesus and His Mom ran on June 5 & 6, 2010. With video created by Ethan Hoenerman and live dancing choreographed by NSM, OOT created a thought provoking and contemporary look at the days leading up to the crucifixion of Christ and how this story impacts our society to this day. Collaboration with BACH and NMS allowed us to reach new audiences, local and multi-ethnic, while exposing those not familiar with opera and classical music, to a rich, cultural experience. Jesus and his Mom enjoyed two sold out performances
