SUMMARY -THE KENNEDY MEMORIAL TRUST IS AN ORGANIZATION WHOSE TRUSTEES INCLUDE THE US AMBASSADOR TO THE UNITED KINGDOM (UK) AND OTHER PUBLIC FIGURES. THE KENNEDY MEMORIAL TRUST IS RECOGNIZED AS A REGISTERED CHARITY IN THE UK. FOLLOWING THE ASSASSINATION OF PRESIDENT JOHN F KENNEDY, AN APPEAL WAS LAUNCHED IN THE UK TO ENABLE BRITISH PEOPLE TO CONTRIBUTE TO A FUND IN HIS MEMORY.
