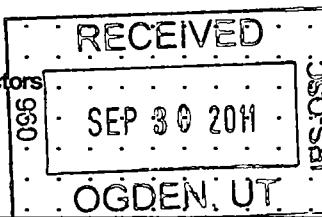

Form 990 EZ 2010 - Part III: Statement of Program Service Accomplishments

The Camden Garden Club has been in existence for 95 years as of this filing. Our mission is to “cultivate the art of gardening in its fullest; and to promote civic improvements.”

Projects for the 2009-2010 year include the following:

**Downtown Beautification:** Planted and maintained hanging flower baskets and numerous flowerbeds throughout the commercial downtown district. Christmas wreaths are displayed in the same area during the yuletide. (\$13,123)

**Tree Replacement Program:** Collaborative effort between the club and the town of Camden to plant new trees throughout the community. (\$1,165)

**Scholarships:** Several college students who are matriculating in horticultural disciplines were awarded funding to augment their tuition. Other funding was given to local youth to attend a 4-H summer camp in nearby Lincolnville, Maine. (\$2,100)

**Educational Programs:** Several informative presentations were offered to both members of the Club and the public alike during the past year. (\$700)

**Donations:** The club distributed funding to other similar entities, both local and national. As such, the “Garden Club Federation of Maine” was given a donation of \$75 for their Daffodil Sale.
