The trust considers itself related through common charitable objectives, and partially through common trustees and/or officers, to the Phi Beta Psi Sorority - Board of Directors (Grand Chapter), EI 32-6-43811, c/o Bev Crittenden, National Treasurer, 10005 Plum Hollow Court, Louisville, Kentucky 40291. The Board of Directors (Grand Chapter) is the parent organization of about 150 affiliated chapters located throughout the United States. The members of each local chapter since 1953 have engaged in raising funds to assist the medical profession in its research for causes and cure of cancer.

Each chapter remits \$1.50 of each members dues, plus other donations from the general public obtained through local fundraising activities, to the Grand Chapter. The Grand Chapter in turn has paid these funds to persons and/or organizations engaged in cancer research.

As of March 10, 1973 the Phi Beta Psi Charity Trust Fund was organized to assume the responsibility of receiving these funds from Grand Chapter and paying them over to cancer research organizations.

Thus, at present, The Phi Beta Psi Grand Chapter (Board of Directors) and its affiliated chapters act as a collection agency for contributions earmarked for cancer research.

Grant recipients must be members of the medical profession who have been or will become engaged in cancer research through the auspices of the American Cancer Society and various medical research centers throughout the United States. Final grantees are recommended by a medical advisory board, then submitted to the Phi Beta Psi Sorority membership at its annual convention (usually in July) for final approval. (This procedure is outlined in greater detail in the trust's application for exemption, Form 1023).
