The organization provided several shipments of medical supplies, equipment and humanitarian aid in  
October of 2010 to Espiranza De Vida in Guatemala who provides ongoing medical care to the needy  
and disadvantaged people of their areas. The regions they serve are some of over twenty targeted  
areas by the World Health Organization to combat various degenerative diseases such as Heart and  
Stroke diseases. Some of these diseases are spreading at epidemic rates. The lack of properly  
equipped facilities and medical supplies further contributes to the ongoing challenge of saving  
lives - especially the children, elderly and the handicapped. Several thousand people were  
served by these In-Kind Contributions.

The organization provided ongoing monetary grants to like-kind charities in the United States, in  
support of ongoing Heart and Stroke detection and treatment programs at hospitals, clinics and  
institutions.

The organization provided ongoing monetary grants to Destiny Medical Fund, which supports ongoing  
Heart and Stroke detection and treatment projects at hospitals, clinics and institutions thruout  
the Philippines. The Fund distributes medical supplies and equipment to hospitals and clinics  
that treat Heart and Stroke and other degenerative diseases. The organization provides ongoing  
monetary grants to Oasis of Hope Hospital in Tijuana, Mexico. Oasis takes a total approach in  
treating individuals with cancer. Oasis promotes holistic treatments that have proven to be  
effective.
