Student Housing/Meeting Space: The sorority house provided student housing for 55 girls for the 2010-2011 school-year. The property can house 68 student members. The goal is to increase live-in membership in the future at or close to the capacity. The property was also used as weekly meeting space for the entire Chapter, approximately 100 students.

Food service: The sorority house maintains a commercial kitchen that provides daily meals for the 55 live-in members and weekly meals for the entire membership of approximately 100. The future goals are to hire kitchen help for preparing, serving, and cleaning up meals (i.e. student busboys).

Employee - House Director: The sorority house is also home to a live-in House Director or House Mom. This is a full-time salaried position. The House Director maintains the house operations and alerts the Board of Directors with issues as needed. The House Director also enforces the standing rules and provides the students with guidance as needed.
