SUPPORT IS ALSO PROVIDED FOR TWO OF THE STATION'S PROGRAMS - THE HIGHLANDS NATURE CENTER AND THE HIGHLANDS BOTANICAL GARDENS, AMONG OTHER FORMS OF DIRECT AND INDIRECT SUPPORT. THE STATION IS A BIOLOGICAL RESEARCH AND EDUCATION FACILITY OF UNIVERSITY OF NORTH CAROLINA SYSTEM.
