In order to assist in the education of future leaders of the construction industry and to create an alliance between themselves and the North Carolina institutions that provide construction industry education, the membership of the Construction Professionals Network of North Carolina, Incl. (CPN) establishes an annual scholarship award.

The organization has developed a program named CPN Institute that seeks opportunities to share our diverse knowledge base with the construction industry and communities in North Carolina. Effective June 24th, 2010, this effort resulted in the creation of a separate 501(c)(3) charitable organization, which is being supported in part by contributions from CPN.
