Anderson University (University) is a comprehensive university affiliated with the South Carolina Baptist Convention offering bachelors and masters degrees The University is ranked in the top tier (top 21) of colleges and universities in the south and is one of "68 Schools to Watch in America," by U S News & World Report The University has also been named one of "America's 100 Best College Buys" Located on 271 acres in the upstate region of South Carolina near the foothills of the Appalachians, the University features a rigorous education in a supportive Chrstian environment The University offers 33 baccalaureate majors with 24 minors The University also offers a master of education, a master of education in administration and supervision, a master of the arts in teaching (MAT) in elementary education, a master of business administration, a master of ministry degree, a master of criminal justice degree, a master of music education, and a doctor of ministry HIGHLIGHTS of YE2011 The 2011 fiscal year saw unprecedented growth as the University entered a sixth year with the University crossing the 2,500 barrier in enrollment for the first time in its history Two new residence halls constructed to accommodate growth were filled to capacity and early commitments from the 2011-2012 freshman class indicated that the growth trend was accelerating rather than leveling out Additionally, a novel concept restaurant, Food for Thought, proved popular with students and eased some of the crowding in the main campus dining facility Plans were developed and a quiet fundraising campaign began for a new student center to be built within the next few years
