Student Aid. Charleston Southern University awards institutional, state and federal financial aid to a rapidly growing student population representing an increase in numbers and academic quality. Ninety-five percent of the student population receives some type of financial assistance. G.I. Jobs, the premier magazine for military personnel transitioning into civilian life, has awarded Charleston Southern University the designation of Military Friendly School for the third consecutive year. The 2012 Military Friendly Schools list honors the top 20 percent of colleges, universities and trade schools that are doing the most to embrace America's military service members and veterans as students.

Instruction. For the academic year 2010-2011 there were over 3,000 students in undergraduate and graduate classes. CSU's Nursing program has the best 3-year pass rate in South Carolina for the N-CLEX licensure exam. Plans have been approved to expand the Nursing Program so that student enrollment in the School of Nursing will triple by 2014. The University will complete the development of online versions of its core curriculum classes in the Spring of 2011. Currently an online Master's in Science in Organizational Management degree is being developed so that students may enroll in that program beginning fall 2012. Our new Graphic Design major is one of the fastest growing degree programs on campus. A second full-time professor will be hired to accommodate student growth (to begin in fall 2011). The School of Education has launched a new "Fast-Track" version of the Master's degree in Education. Students can complete the degree in 15 months.

Student services. Enrollment services, university registrar, counseling, sports, and recreation. Charleston Southern University has been named "One of America's Best Christian Colleges" by Institutional Research Inc. for the 13th consecutive year and, in 2010, CSU was selected to the "President's Higher Education Honor Roll" for exemplary service to the community. The success is a reflection of CSU's pursuit of reaching our vision of being a Christian University nationally recognized for integrating faith in learning, leading and serving.
