In 2000, Memorial Park Conservancy (MPC), in partnership with the Houston Parks Board and Houston Parks and Recreation Department, began a process including public comment to develop a Conservation Master Plan for Memorial Park The Master Plan was approved by the Houston City Council in 2004 As a result, MPC announced a \$10 million Capital Campaign to raise funds for major projects and improvements in Memorial Park MPC has raised significant funds and is in the process of executing the projects included under the Capital Campaign In FY 2011, MPC continued construction of Phase 1 of the Outer Loop Trail, an all-weather multi-use trail that connects the Living Bridge (constructed in FY 2010) to the north entrance of the Park, and is expected to be completed in FY 2012 Phase 2 of the trail is anticipated to begin in FY 2012 MPC also engaged an architectural firm to complete a design charrette for a Running/Trails Center to be constructed on the south side of the Park near the Living Bridge Construction for the Running/Trails Center is expected to begin in FY 2012

Memorial Park Conservancy contracted professional forestry consultants for the implementation of the Memorial Park Forest Management Plan on a defined portion of the Park The foresters assessed, identified and prioritized this treatment area concerning invasive/exotic plant species, forest canopy type, understory density and composition, and the presence or lack of tree generation The data was uploaded to field computers running GPS and GIS software, and a preliminary implementation design was prepared Memorial Park Conservancy contracted a public relations firm to inform and educate the public regarding the forestry plan

Preserving and conserving the natural habitat of Memorial Park for the public's benefit and enjoyment requires ongoing maintenance programs The Volunteer Supervisor Program, directed by MPC's volunteer coordinator, was established in FY 2011 to expand volunteer hours and efforts devoted to such maintenance programs Volunteer supervisors must demonstrate leadership qualities, complete a certification process and receive CPR training Maintenance projects include invasive species removal, weeding, planting, gardening, trash pick-up, and ongoing reforestation efforts The volunteer coordinator works in partnership with the Houston Parks & Recreation Department to prioritize and plan the projects
