The event spotlights FPA's core competencies of: Knowledge, Community, Advocacy and Leadership. Registrations showed a modest improvement over 2009, with total registration revenue at \$859,325, up \$94,299. Total registration was 2432 over 2248 in 2009. This was viewed as a positive indicator for future conference performance. Many exhibitors expressed their satisfaction with the exhibit hall traffic and had an overall positive experience with the target audience. The Professional Development Pavilion in the exhibit hall offered attendees additional education and CE opportunities, with several sessions' standing room only. The new FPA brand was launched during the conference and was

Member Relations is also responsible for serving members by answering their questions and addressing their concerns as well as ensuring that they are taking full

It is an event that attracts the "best and brightest" of the profession due to its level of intimacy, community learning and advanced, cutting edge content. Retreat this year represented a highly positive turning point due to its great performance. Registration revenue exceeded budget by approximately \$45,000. The sponsorship model was adjusted to maximize revenue opportunities and ensure an excellent experience for sponsors and attendees alike. Cost savings managed by the Meetings department contributed to the overall positive net revenue results for the organization.




