The Blaine County Education Foundation provides direct financial support to all 8 county public schools to advance the quality of education provided to students in Blaine County. We give grants to teachers and classrooms that encourage the use of twenty-first century skill, such as project-based and student-directed learning. In addition we provide scholarships, teacher professional development, and aid to underprivileged students. We are currently in the process of developing an enrichment academy for students after school and in the summer.

The down payment assistance program allowed two teachers to receive enough assistance to purchase a home in Blaine County and ensuring their commitment to the quality education to Blaine County students.
