During the year, MDNA has had 28 admissions and 36 discharges including 8 deaths. MDNA nurses have called the ambulance 6 times on behalf of patients. A total of 131 patient visits were made to the office. This number does not include all the visits from persons borrowing Loan Closet Equipment. The Loan Closet provided durable medical equipment to 210 Mount Desert Island residents, for a total of approximately 558 pieces of loaned equipment. Most of this equipment is returned within a few weeks or months and then needs to be cleaned and restocked into the basement.

In addition to regular patient care visits, the nursing staff spends many hours conferencing with health care professionals, individuals, and families by phone. During the year our RNs have made approximately
