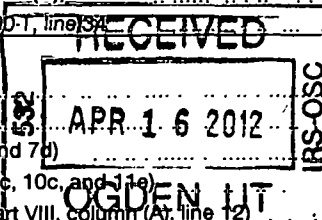

planning needs of approximately 30,000 low-income Maine women, men and
teens annually. FPA's services are confidential, offered on a sliding
fee scale, state-of-the-art, and include:

> Comprehensive medically accurate reproductive health care information
to help clients make informed decisions about their reproductive health
and lives

> Gynecological exams

> Colposcopy for evaluation of abnormal Pap tests

Education and Research Projects: The FPA's Male Involvement Project
addresses family planning and reproductive health information and
services for males. While research shows that young men recognize
unintended pregnancy, STDs, and HIV/AIDS as serious problems, and
acknowledge that prevention is a joint responsibility, experience has
shown that drawing them into family planning/reproductive health
information and service programs requires approaches that focus on
their needs.

During FY 2011, all Maine family planning programs-as part of the Male
Involvement Project-provided free chlamydia and gonorrhea screenings
for low-income men without insurance or means to pay for the

Agency and Mission-related Projects: The FPA's Public Affairs staff
since 1971 has worked to protect the reproductive rights of all Maine
citizens. The Family Planning Association is founded on the premise
that Maine women and teens must have access to comprehensive
reproductive health care and information in order to control their
reproductive lives. The FPA Public Affairs efforts are designed to
promote and protect programs and services statewide to ensure
affordable access to family planning.

While the Family Planning Association has faced and overcome many
challenges to the rights and freedoms that we protect each day, the
battles have increasingly become more difficult. Specifically,
anti-choice, anti-family planning forces have galvanized significant

During 2011, 82% of our clients were low-income and a visit to one of our centers was often the only health care they received. Half of all sexually active Maine teens sought counseling and services from a family planning health center and many of these young people continue to use our trusted services through adulthood. In 2011, 6,816 teens were provided the care they needed to prevent unintended pregnancy and the spread of sexually transmitted diseases. 75.2% of teen clients involved a parent in their decision to come to family planning.

Once one of the highest in the nation, Maine now has the 7th lowest teen birth and the 3rd lowest teen pregnancy rate in the country. In the last decade, Maine's teen pregnancy rate has dropped by 27%--one of the most dramatic improvements in the country.

Building community partnerships, on-line and offline communications and marketing, off-site testing, fee assistance, and extensive community outreach and education has maintained a significant number of male family planning clients.

In 2011, Project Connect-a two-year violence prevention initiative to improve the health and safety of women and children-developed policy and public health responses to domestic violence and sexual assault within the clinical setting.

In a recent statement from Family Violence Prevention Fund President Esta Soler noted, "It will help prevent domestic, dating and sexual violence; help train the next generation of health providers to do this work; and help reduce unplanned pregnancy by promoting collaboration between the violence prevention and reproductive and child health care systems."

Similar to our Community-based services, funding for the FPA's education and research projects is provided by State and Federal agencies (that also monitor program operations and outcomes), foundation grants and other restricted revenues.

Through testimony and many private meetings with lawmakers throughout the session, FPA fought to maintain adequate funding for Maine's core family planning health services-and we won. As a result, Maine women, men, and teens can remain secure in their ability to access affordable reproductive health care. In the final hours of budget negotiations, Maine's Legislature restored more than \$400,000 of proposed cuts recommended by the Administration. By doing so, they helped us keep the doors open for our most rural health centers.

Access to reproductive rights faced additional challenges in Maine this year with an increased number of anti-choice bills. Despite this, FPA and its supporters upheld Maine's pro-choice legacy by sending more than 2,000 emails and attending public hearings. We beat back calls for 24-hour waiting periods, parental involvement, scripted counseling, parental consent for birth control, and legislation seeking to establish fetal rights.

Private contributions and agency-endowed resources fund these projects. No public funds are used.
