THE BANGOR PUBLIC LIBRARY CONTRIBUTES TO THE PROSPERITY AND GROWTH OF BANGOR BY PROVIDING EXCELLENT LIBRARY SERVICE. LAST YEAR THE LIBRARY CIRCULATED 418,287 ITEMS TO 33,850 REGISTERED BORROWERS. OVER 226,400 PEOPLE VISITED THE LIBRARY IN 2011, OR AN AVERAGE OF 786 PEOPLE A DAY. AS WELL AS THE 64 PUBLIC ACCESS COMPUTERS AND FREE WI-FI ACCESS, THE LIBRARY HAS A COMPUTER LAB TO PROVIDE BOTH COMPUTER CLASSES AND ONE-ON-ONE TUTORING.
