THE ORGANIZATION'S PRIMARY ACCOMPLISHMENT IS THE OPERATION OF A SCHOOL. THE ENROLLMENT HAS GROWN TO 94 STUDENTS WHO ARE ON-SITE 6 HOURS PER DAY, 5 DAYS A WEEK. THE EARLY CHILDHOOD PROGRAM SERVES CHILDREN 18 MONTHS TO 5 YEARS OLD AND OPERATES ON A 12 MONTH SCHOOL YEAR. A SCHOOL AGE PROGRAM PROVIDES ACADEMIC INSTRUCTION FOR CHILDREN AND ADOLESCENTS 5 YEARS TO 22 YEARS OLD AND OPERATES ON A 10 MONTH SCHOOL YEAR WITH A 2 MONTH EXTENDED SUMMER PROGRAM (SEE PART III, 4C). YOUNG ADULT STUDENTS OVER AGE 16 LEARN TO FUNCTION INDEPENDENTLY THROUGH THE CENTER FOR LIFE SKILLS AND EMPLOYMENT. THIS EDUCATIONAL PROGRAM WAS THE 2009 RECIPIENT OF THE VIRGINIA DEPARTMENT OF REHABILITATIVE SERVICES COMMISSIONER'S TRANSITION AWARD OF EXCELLENCE.

FAISON PROFESSIONALS ALSO OFFER COMMUNITY EDUCATION PROGRAMS, SCHOOL CONSULTATIONS, AND PROGRAM EVALUATIONS.
