Our Capacity Building Program features working partnerships with particular constituencies: BASE (Building Action for Sustainable Environments), organized around chemical weapons, military and civilian nuclear industries and alternative sustainable economies and their impact on health and climate change; Criminal Justice Initiative, building a national movement of formerly incarcerated people, their families and allies; Middle East Peace Initiative, supporting the plurality of progressive voices in the United States who work for a peaceful, secular and comprehensive resolution to the Palestinian-Israeli conflict and humanitarian crisis; and our Community Advised Funds, an effort to bring donors, grass roots organizers and funders together for grantmaking and community building, strengthening relationships across sectors of the social justice movements.

A total of 16 grants were made.
