License Plate Program - The "I'm Animal Friendly" license plates support spay/neuter efforts in Massachusetts and helps to reduce the number of homeless animals in the state.

PILOT for Pets is a Massachusetts based program, created by members of the Massachusetts Animal Coalition (MAC) that enables animal welfare organizations to work together to successfully transfer dogs that are in need of placement.

(Code) (Expenses \$ 10,931 including grants of \$ 26,820) (Revenue \$)

MAC members and volunteers have joined together to create task forces (some temporary until a specific problem is resolved and some more permanent) to work collaboratively on specific projects. Currently, the Pit Bull Spay/Neuter task force has been created to decrease the numbers of Pit Bulls surrendered to animal shelters, rescue groups and animal control organizations by promoting spay and neuter programs for Pit Bulls and improving the image of the breed. Additionally, the goal of the Spay Worcester task force is to work to reduce the population of free roaming cats in the city of Worcester through spay neuter programs and public education.
