WHILE THE SCHOOL RECEIVES THESE SERVICES AND RELATED EQUIPMENT NO FUNDS ARE ACTUALLY RECEIVED BY THE SCHOOL AND CONTRACTUAL RELATIONSHIPS AND PAYMENTS REMAIN BETWEEN THE TOWN AND CONTRACTOR AND OWNERSHIP OF ANY RELATED EDUCATIONAL EQUIPMENT ALSO REMAINS WITH THE TOWN AND NOT ST ANDREWS. IT IS ESTIMATED THAT THE TOTAL VALUE OF GOODS AND SERVICES RECEIVED DURING THE FISCAL YEAR ENDING JUNE 30, 2011 APPROXIMATED \$69,205.
