College and Masters/Doctoral Programs Saint Joseph College, which offers outstanding educational value in undergraduate, masters and doctoral programs, is located in West Hartford, Connecticut. Enhanced by the Catholic intellectual tradition and the values of the Sisters of Mercy, the College encourages students to thrive in a culture of achievement and collaboration. With small classes taught by expert faculty, the College provides a values-centered education in an environment that fosters leadership, confidence, and creativity. In addition to the Undergraduate Women's College with 901 students enrolled, Saint Joseph College has a co-educational graduate and professional studies program offering master's degrees and certificates to 1,267 students, a co-educational weekend program serving 158 adult learners pursuing their baccalaureate degrees, and a School of Pharmacy, located in downtown Hartford, offering a unique three calendar year co-educational doctoral degree (Pharm D) program in pharmacy. The School of Pharmacy's inaugural class began in August, 2011, with 67 students.

Model Schools The College is home to two model schools. The Gengras Center and The School for Young Children. The Gengras Center is a state-approved private special education facility that provides highly structured, intensive and self-contained special education programs for elementary, middle and high school students. Saint Joseph College students fulfill required classes in the fields of special education, nursing, social work, counseling and nutrition at the Center. The School for Young Children is a nationally-accredited preschool serving 140 children since 1936. It serves as a training program for college students pursuing careers in early childhood education and related fields.
