Connecticut Legal Services provides civil legal representation and counseling to help low-income individuals (adults and children) and families obtain just legal solutions to serious life problems. We assist our clients to use the law to help themselves climb out of poverty, improve their lives, and build better futures for their children. Our areas of specialty include domestic violence/family, homelessness/housing, public benefits and employment, education and juvenile, elder, and disability law. During the 2010/2011 fiscal year, CLS advocates provided assistance to 4,618 low-income households consisting of 10,267 individuals, including 3,984 children. Advocates also worked on 3,502 active cases that were brought over from the prior fiscal year. In addition, 195 outreach/community legal education events were held throughout our service area, reaching over 7,900 individuals. Approximately 6,200 legal educational pamphlets were distributed at these events.

During the 2010/2011 fiscal year, Connecticut Legal Services received a total value of \$258,818 in donated services to support the work described above.
