Outreach Schmahl Science Workshops serves pre-kindergarten through high school students with over 550 hands-on workshops throughout Silicon Valley Each workshop integrates the concepts and skills measured in California's STAR English-Language Arts, Integrated Mathematics, and Science standards, providing teachers with the opportunity to simultaneously cover multiple subjects and thereby conserve valuable time Middle and high school workshops support science teachers by bringing in workshops at key times during each unit of science instruction and providing students with hands-on activities and experments that are not commonly available We served 32,000 pre-school through high school students served in our programs last year We saw each child 26 times in the year 51% were Latino, 5% were African American, 52% were young women, and 72% lived in low income communities

Advance Student Research Program (ASRP) This is a fifteen-year-old innovative program that prepares sixth through twelfth grade students to consider science as a viable career option and to major in science in college ASRP provides an opportunity for bright young students to develop a passion for science by conducting authentic research and producing quality projects In 15 years, hundreds of students have received awards for research projects Currently, eight ASRP students are working with volunteer patent attorneys to patent their discoveries One young ASRP scientist was recently published in the Nature journal
