**Explanation****Philanthropy**

The Asian American Community Fund, the Federation's annual grant making program, made \$216,500 to 12 grant awards. Since 1993, the Federation has supported critical programs for Asian American individuals and families through its annual Community Fund, awarded to local community organizations through a competitive application process. For example for FY 2010-2011, the Greater Chinatown Community Association was awarded a program grant to implement its Digital Connectors Project that helps underprivileged youth gain technological and career development skills. The South Asian Council for Social Services received a grant to develop a South Asian Mental Health Support Network that provides culturally and linguistically relevant mental health services to seniors.

The Asian American Federation's annual gala recognized distinguished honorees who have made significant contributions to the Asian American community, promote and empower the role of Asian Americans in society, or exemplify the spirit of Asian America. On May 5, 2011, the Federation honored the accomplishments of three outstanding community leaders: Linda Lam, Managing Partner, Northeast Sub-Area Assurance of Ernst & Young LLP, Yong Hwa Ha, 31st President of the Korean American Association of Greater New York and President of Solomon Agency Corporation, and Judge Judith Sheindlin, Presiding Judge of Judge Judy. Proceeds from the evening go towards supporting the New York metropolitan area's Asian American communities and nonprofits.

On November 9, 2010, the Federation hosted its 2nd Annual Charity Bowl-A-Thon. Over 70 guests from 10 companies including Goldman Sachs, HSBC, Time Warner and Verizon competed and raised funds for community agencies with programs battling poverty and hunger. The Federation also organized public events for its donors and sponsors, including a holiday reception on December 7, 2010. For its 3rd Annual Asian American Golf Classic on June 13, 2011, the Federation partnered with United Healthcare to organize a fundraising and networking event. Proceeds benefited the Federation's ongoing programs for our member agencies and Asian Americans in need within our own New York metro/regional area.

**Capacity Building**

To address the needs and concerns of its member agencies that directly serve the Asian American community, the Federation provided an array of capacity building opportunities. Capacity building support included workshops and trainings for agencies to help overcome the effects of the recession, and strengthen their fundraising, grantmaking and development ability such as fiscal contingency planning, and building a stronger board.

**Policy & Research**

The Asian American Federation completed its Census 2010 Community Engagement Campaign that involved a total of \$880,000 made possible by funding from a private foundation and the New York State Department of State. These grants were distributed to 36 community organizations marking an unprecedented level of support to mobilize grassroots organizations in the Asian

American community for Census 2010 outreach and promotion in the Northeast region. For Constitution Day on September 17, 2010, the Asian American Federation and their community partners celebrated the successful campaign with a recognition reception and ceremony followed by a day of discussion where community leaders discussed strategies to effectively outreach to Asian Americans, how to use census data to make informed decisions that impact the Asian American communities, and ways to continue and improve census participation through 2020.

With the release of the 2010 Census data that began since January 2011, the Federation's Census Information Center (CIC) has been instrumental in providing trainings, webinars, presentations and reports to help community organizations, government agencies, media, educational institutions, businesses and the general public to identify the needs of the Asian Americans they serve, improve service access and inform policymaking. The Federation presented Census data results at the Asian/American Center of Queens College and Asian Americans for Equality's Fourth Annual Asian American Community Development Conference, as well as co-hosted a meeting of New York City community groups to discuss the basics of redistricting. The Federation reported that the Asian population in New York City grew by 32 percent, faster than every other major race and ethnic group, save for American Indians and Alaska Natives, Asians are now close to 13 percent of New York City's population.

The Asian American Federation also facilitates collaboration among member and community agencies, and forms coalitions to work together in responding to emerging community needs and advocating for the Asian American community, including appealing to newly elected Governor Andrew Cuomo on November 9, 2010 with United Way of New York State, UJA-Federation of Jewish Philanthropies, and New York State Coalition for Children's Mental Health Services to preserve core services that focus on prevention, protection of the needy and address the needs of working families.

The Federation successfully convened four member agencies and five local funders to initiate a Robert Wood Johnson Foundation grant, Project Speak Out. A joint program of the New York Asian Women's Center with Garden of Hope, Korean American Family Service Center and Sakhi for South Asian Women, this initiative was the first large scale pan-Asian domestic violence prevention campaign in New York City aimed to change individual and community attitudes and behaviors toward intimate partner violence/domestic violence. The Federation also led the effort to bring together local foundations to nearly double matching funds for the \$200,000 grant.
