The Peace Appeal Foundation works to catalyze social change processes designed to reduce violent conflict, end wars and lay the groundwork for sustainable, just peace. To this end, we work with individuals and communities in societies in conflict (from senior political leadership, to religious and civil society leaders to local populations) as well as other international stakeholders to develop the processes, programs, structures and institutions that will support the transformation of their conflicts. We also seek to help improve the practice of peace building more broadly through research, education and other initiatives to enhance the understanding and effectiveness of peace initiatives globally.

In our work, we rely on the talents and generosity of many individuals and institutions who volunteer their time and skills to assist our peacebuilding efforts. In the past year our work continued to support innovative multi-stakeholder structures and processes in Lebanon, Nepal and Sri Lanka. Our small grants program continues to provide support to the Common Space Initiative Library in Lebanon, where Lebanese individuals working for peace can access a global treasure of publications, books, manuals, periodicals, etc. on peacebuilding related topics.

In FY 2011, we continued a multi-year initiative to research and document the emerging role of peace structures in peacebuilding and conflict transformation efforts globally. We have been pleased to see a growing interest in the topic, often phrased as “infrastructures” for peace. Additionally in the past year we furthered our plans in partnership with two international institutions to launch an online resource for practitioners in our field on peace structures, which we anticipate to go live in 2012.

Domestically the Peace Appeal and our associates continue to present to public audiences on the role of national dialogues and multi-stakeholder structures which engage both political stakeholders and civil society in support of peacebuilding initiatives. Through our participation in several networks of US and international peacebuilding organizations, we also seek to raise the visibility of the contributions of non-governmental actors in crucial peacebuilding efforts, and the need to support those efforts through improved legislation and financial resources.
